

MINUTES
REGULAR MEETING, MAY 10, 1994

The regular May, 1994, meeting of the Collinsville City Council was convened at 7 p.m., by Mayor Quattlebaum. Present were Councilmen Meador, Enderby, Perdue, and Anderson. Also Councilman Elect Wayne McCorkle.

Minutes of the previous meeting were approved by a motion by Mr. Enderby, seconded by Mr. Anderson, and carried.

The financial reports were approved by a motion by Mr. Enderby, seconded by Mr. Meador, and carried.

Old Business.

B. The second reading of Ordinance #302, a two hour limit parking ordinance, was approved by a motion by Mr. Enderby, seconded by Mr. Meador, and carried.

C. The resignation of James Johnson from membership on the Council was approved by a motion by Mr. Enderby, seconded by Mr. Anderson, and carried.

D. Mayor Quattlebaum, Councilmen Meador and Anderson retired at 7:12 p.m. and returned at 7:16 p.m. for canvassing of the vote from the recent election. The count as given was approved by a motion by Mr. Meador, seconded by Mr. Anderson, and carried.

E. Swearing in of officers was conducted as Mayor Quattlebaum took the oath from Mr. Enderby, Mr. Perdue, and Mr. McCorkle. There was a short discussion concerning the appointment of a person to complete the unexpired term of James Johnson.

A. The Mayor gave a status report of plans for some minor work which will begin if it ever stops raining. He then spoke to several questions, issues, concerns about which he urged the Council to give immediate and serious consideration: 1) manager/mayor for the administration of City affairs at the end of this mayoral term, 2) implementation of the planning grant procedures, 3) a plan for sludge removal. Todd Henry brought information relative to truck costs, entry into landfill costs, etc., 4) condemnation of unsafe, unsightly buildings around town, 5) forced removal or inclosure of vehicles not operable, not having current inspection sticker, not having current registration, 6) forced cleanup of property including grass, weeds, junk and standing water.

New Business.

A. A discussion of the use of a single, two inch meter, for service to property to be used for dwellings for the use of more than one family or individual. The sewer charges to be prorated against the water usage. The property owner would be responsible for installation costs and water/sewer charges. The motion to approve the drawing of such an ordinance was made by Mr. Enderby, seconded by Mr. McCorkle, and carried.

B. Ordinance #303, confirming tap fees for water and sewer installation inside the city limits and for water outside the city, was approved by a motion by Mr. Enderby, seconded by Mr. McCorkle, and carried.

C. A motion was made by Mr. Enderby, seconded by Mr. Anderson, and carried, to authorize the Mayor to request Southwest Consultant to prepare the request for Planning Proposal Documents.

A motion to adjourn was made by Mr. Anderson, seconded by Mr. Enderby, and carried at 8:15 p.m.
