MINUTES REGULAR MEETING

Monday, May 9, 2016 @ 6:30 P.M. Collinsville City Hall / 101 North Main Street

Mayor Brandon R. White, Council members Grady J. Carney, Andy R. Hammer, Brian K. Radcliff and Gina L. Richroath were in attendance. City Secretary Troy M. Vannoy recorded these minutes.

- **1. Call to Order:** Regular meeting was called to order by Mayor Brandon R. White at 6:30 p.m.
- **2.** Pledge of Allegiance/Invocation: Meeting opened with the Pledge of Allegiance led by Mayor White & Invocation offered by Don R. Graham.
- **3. Roll Call and Determination of Quorum:** Mayor Brandon R. White declared a quorum present and opened the Regular Meeting.
- **4.** Consent Items consisting of April 11, 2016 Regular Meeting Minutes and April Financial Report: Motion made by Gina L. Richroath, second by Brian K. Radcliff and carried 4-0 to accept all consent items as presented.
- **5. Citizens to be heard:** Charles Bitsche and Chase Guidera, both residents living on the 100 block of Murdock Street approached the council with concerns about the drainage of the ditches on Murdock Street. Mayor White addressed their concerns by stating that the county has been hired to do 40 hours of drainage work around town and he will make note of their concerns.

6. Police Department:

A. Monthly Report: Chief Roach presented the council with a report of his department's activities for the month of April. A copy of the report will become a part of these minutes.

7. Public Works Department:

A. Monthly Report: Mark or David Patterson was unable to attend.

8. Fire Department:

A. Monthly Report: Chief McKee states that for April, there were 31 calls for service. The Fire Department worked during the bad weather clearing brush off the streets providing citizens access in and out of areas about town. Some communication issues between different departments was discovered during the recent power outage and these issues will be addressed for future improvements. The warning siren located at the City Park is currently nonfunctional and will need to be replaced. The old Chevy Suburban will soon be put out for bids.

10. Keep Collinsville Beautiful:

A. Monthly Report: Betty Graham, KCB Chairperson reports that TxDOT has informed her that if we want a new flag pole, this will be at the city's expense. Lights still need to be refurbished and installed by the city. The CEDC and KCB are working on reconfiguring the parking downtown, but final work cannot be done until the TxDOT project is completed. A combination CIDC/KCB open house is scheduled for July 16 to dedicate their projects with more information to be determined and coming at a later date.

11. Collinsville Park Board Report:

A. Monthly Report – Melody Graves reports that currently the pavilion at the park is being taken down for relocation at a later date. No other information at this time.

12. Chamber of Commerce Report:

A. Monthly Report – Loula Pingleton, President of the Chamber of Commerce states that G. G. Cox is the Vice President and will be heading up Pioneer Day.

13. Mayor Report:
